

Highlights of the 39th session of the Executive Body

ENVIRONMENT

- Launch of the review of the Gothenburg Protocol as amended in 2012 following the entering into force of the GP on 7 Oct 2019 – Parties, all Convention bodies, centres and task forces will contribute to the review process in the coming years
- Highlights of the 2018-2019 workplan; adoption of the 2020-2021 workplan
- Adoption of the revised mandates for all EMEP and WGE centres and task forces (Executive Body decisions 2019/6 – 2019/21)
- ICP Modelling &Mapping now includes two centres: Coordination Centre for Effects and new Centre for Dynamic Modelling (former JEG DM)
- Adoption of the updated Monitoring Strategy for EMEP 2020-2029



40th Anniversary of the Convention including high-level session

- Awareness of the achievements of the Convention and the tools and benefits it has to offer
- Progress made and priorities for the future
- Two dozen high-ranking representatives from Parties and international organizations (WHO, WMO, CCAC, UN Environment)
- Declaration on Clean Air for 2020–2030 and beyond in UNECE region
- Cooperation on clean air with non-ECE partners establishment of the Forum for international cooperation on air pollution

ENVIRONMENT

5th Joint session of EMEP Steering Body/Working Group on Effects (September 2019):

- Updated Monitoring Strategy for EMEP; updates of the EMEP/EEA Guidebook; a new setup for TF HTAP: US and Canada supported by Germany and Poland
- Thematic sessions: on nitrogen and black carbon (extensive contributions by centres and TFs); various recommendations for further research
- Information sharing by Parties and partner organizations and projects
- Progress of the study on UNESCO World Heritage Sites by ICP Materials special thematic report
- Health: WHO AQGs update; joint capacity-building workshops organized by WHO with support from the Convention secretariat
- Proposal for a new Centre on Dynamic Modelling under ICP Modelling and Mapping; focus
 on: ecosystem modelling and effects of air pollution on biological diversity
- Call for data by ICP Vegetation regarding heavy metals, nitrogen and POPs concentrations in mosses (2020/2021)

2020

- Training sessions on the development of national emission inventories in Kazakhstan, Kyrgyzstan and Republic of Moldova (September November 2020)
- Joint meeting of the EECCA Coordinating Group and TFTEI to exchange information and share experience on BAT implementations (Minsk, Belarus, 29-30 September)
- Development of National Action Plan for ratification for Kazakhstan (2020-2021)
